

RICOH ProcessDirector 3.1 Postal Enablement Feature

Overview

RICOH ProcessDirector is an extensible, configurable output process management system that lets you start small and grow over time. With core capabilities plus optional add-on features, RICOH ProcessDirector allows flexible control of your print and mail production processes. It can streamline operations, improve process integrity, enhance operator productivity, reduce errors, and help lower costs.

RICOH ProcessDirector is also the backbone software of RICOH Automated Document Factory solutions: Mailroom Integrity, Postal Optimization and Output Management.

Mail is expensive. The cost of preparation, materials and postage is high and going higher. The vast share of the cost results from inefficiencies, incorrect addresses, wasted postage and inability to qualify for the deepest postal discounts. With manual mail processes for fully composed documents, however, it's difficult if not impossible to shift gears and address costly bottlenecks—especially as mail volumes grow and postal regulations and tools become more complex.

The new RICOH ProcessDirector Postal Enablement Feature allows users to easily identify and extract addresses from AFP and PDF documents and provide these addresses to 3rd Party Postal Optimization software. The cleansed and sorted addresses can then be easily imported and applied to the original documents as part of a workflow.

The address information can be optimized by software provided by Bell and Howell (e.g. Mail Manager) or TEC Mailing Solutions, or other US or non-US based postal software for address cleansing, suppression and sorting.

Once configured, the identification of address information to send to postal software and the processing of cleansed and sorted addresses can be automated for each mail application, reducing your postal costs and errors. Depending on the specific postal software and its method of accepting and returning files, you can also include those steps in a workflow to more fully automate your postal processing
